

Edmonton's Countryside Getaway Package Contest

Official Contest Rules and Regulations

1. Eligibility: To be eligible for this Contest, a) be a legal resident of Canada, b) an individual must be the age of majority in Alberta (18 years of age). Operators in the Edmonton Countryside Spring Drive and members of their immediate family are not eligible to participate in the Contest.
